

Terms of Use & API License Agreement

Overview

All use of the website, information, services, and content distributed through or in conjunction with or made available on the website is offered to you subject to your acceptance of these Terms & Conditions, our [Privacy Policy](#) and [Permitted and Prohibited Uses Policy](#). By purchasing any goods or services from this website, you are furthermore bound by this site's [Service Agreement](#).

The following terms and conditions incorporate a legal agreement between you (“You”) and AFFNETWORK LIMITED (“AFFNETWORK LIMITED”, “checknumber”) and set forth the terms and conditions by which AFFNETWORK LIMITED will make the checknumber API service available in order to electronically provide You with use of and access to checknumber Data & Services.

checknumber API Services

For the purposes of this Agreement, “checknumber API Services” shall consist of:

- all data and information feeds, media, software, and/or electronic documentation made available or supplied by AFFNETWORK LIMITED or its licensees and
- certain other software, data, and/or documents supplied by AFFNETWORK LIMITED or its licensees to facilitate use of such data or services. “checknumber API Data and Services” means AFFNETWORK LIMITED’s service or application programming interface that allows You and other authorized licensees to access checknumber API Data & Services and make use of checknumber API Services. This Agreement includes all amendments, addendums, and revisions to the terms herein in effect between You and AFFNETWORK LIMITED from time to time.

Acknowledgement

By accessing or otherwise using the checknumber API, You acknowledge that You:

- have read all of the terms and conditions of this Agreement;
- agree to be bound by the terms and conditions of this Agreement;
- agree to check the checknumber API pages from time to time for any updates or amendments to the terms and conditions of this Agreement; and,
- have the power and authority to enter into this Agreement. If You do not acknowledge the above, You may not access or use the checknumber API. If You are dissatisfied with the terms, conditions, rules, policies, guidelines, or practices of AFFNETWORK LIMITED, Your sole and exclusive remedy is to discontinue accessing or otherwise using the checknumber API.

Scope of License

Grant of License

AFFNETWORK LIMITED hereby grants to You a non-transferable, non-exclusive, revocable, and limited license for the term of this Agreement to access the checknumber API and use checknumber API Data & Services strictly for the limited purposes, and under the terms and conditions, as are set forth in this Agreement.

Scope of the checknumber API License

Subject to Your compliance with the terms of this Agreement, You are hereby permitted to receive, process, and display checknumber API Data & Services to individual end-users of your application(s), provided

- such end users use checknumber API Data & Services strictly for their own personal use,
- You do not permit Your end users to store, distribute, or otherwise exploit checknumber API Data & Services for any other purposes.

For clarity, and without limiting the forgoing, You are permitted solely to use checknumber API Data & Services for reference by Your end users. Except as expressly provided herein, under no circumstances whatsoever may You transfer or permit the transfer of checknumber API Data & Services outside of your application(s).

Use of License

Restrictions

You shall not:

- reproduce, copy, modify, distribute, market, display, transfer, sublicense, assign, prepare derivative work(s) or adaptation(s) based on, sell, exchange, barter or transfer, rent, lease, loan, time-share, resell, or in any other manner exploit checknumber API Data & Services or the checknumber API;
- make access to checknumber API Data & Services or the checknumber API available to unauthorized parties, or otherwise post or distribute checknumber API Data & Services in any public forum including, but not limited to, print, newsletters, radio, television, or internet;
- remove, obscure, or alter any required notice or any notice of AFFNETWORK LIMITED's intellectual property rights present on or in the checknumber API, including, but not limited to, copyright, trademark, and/or patent notices;
- disassemble, translate, reverse engineer or otherwise decompile checknumber API Data & Services or the checknumber API;

- use checknumber API Data & Services or the checknumber API in any manner or for any purpose that violates any law, regulation or right of any person.

Attribution

While usage of the checknumber API is not subject to Your end users being made aware by You that AFFNETWORK LIMITED is supplying the functionality you are making use of in your application(s), Your inclusion of a clickable hyperlink to the checknumber API website at <https://checknumber.online> would be highly appreciated.

Your Responsibility to Safeguard

You shall use Your best efforts and take all necessary steps to safeguard checknumber API Data & Services to ensure that no unauthorized reproduction, publication, disclosure, modification, distribution, or other use of any checknumber API Data & Services is made in whole or in part. To the extent that You become aware of any such unauthorized use of checknumber API Data & Services, You shall immediately notify AFFNETWORK LIMITED by emailing "support@checknumber.online".

Misuse of the Licensed Product

In the event that You or any end users use checknumber API Data & Services or the checknumber API in violation of this Agreement, as applicable, AFFNETWORK LIMITED shall have the option of electing liquidated damages.

Services and Data

Use of the checknumber API

Subject to the terms herein, AFFNETWORK LIMITED will provide You with access to checknumber API Data & Services over the Internet through the checknumber API. All calls to the checknumber API must reference the credentials issued to You by AFFNETWORK LIMITED. You may not disclose Your credentials to any other party. You are solely responsible for ensuring the secrecy and security of Your credentials and will be responsible for all activities that occur using such credentials. You shall not use the checknumber API in a manner that exceeds reasonable request volume or constitutes excessive or abusive usage.

Usage Limits

The extent of Your usage of the checknumber API is dependent on Your subscription plan. You shall not exceed the usage limits associated with Your account. Unused amounts of call usage will not be carried over from one monthly period to the next. If You exceed Your monthly usage limit, the checknumber API will return an error message stating that Your monthly usage limit has been reached and no further API calls can be made within the current monthly term. It is Your sole responsibility to ensure that your application(s) properly detect and handle any returned error messages. AFFNETWORK LIMITED will make reasonable efforts to help You identify and resolve usage problems, or to review the suitability of Your current subscription plan for Your needs. AFFNETWORK LIMITED reserves the right to limit or throttle the number of network calls available to Your application(s) if AFFNETWORK LIMITED (in its sole discretion) believes that such calls are being made for malicious reasons, or as the result of a technical error.

Responsibility for Software and Hardware

You shall be solely responsible for acquiring, providing, and maintaining all software/hardware and Internet Services required to access the checknumber API, including but not limited to telecommunication and internet connections, ISP, web browsers, and/or other equipment and software required to access and use the checknumber API.

Services May Be Inaccessible Or Inoperable

You hereby acknowledge that from time to time, the checknumber API may be inaccessible or inoperable for any reason, including, without limitation:

- periodic maintenance procedures or repairs which AFFNETWORK LIMITED may undertake from time to time; and/or,

Service Level Agreement

If the checknumber API is unavailable to all checknumber API customers for more than three consecutive hours in any one calendar day, beginning at 12:00:01 AM London time (GMT + 01:00) and ending at 11:59:59 PM London time (GMT + 01:00) of the same day, an outage will be deemed to have occurred. If there are more than three outages within any one calendar week, beginning at 12:00:01 AM London time (GMT + 01:00) on a Monday and ending at 11:59:59 PM London time (GMT + 01:00) on a Sunday, then You may terminate this Agreement, without liability, by providing written notice to AFFNETWORK LIMITED of Your intention to do so within one calendar week of the third outage. Upon such termination being accepted by AFFNETWORK LIMITED, You shall be entitled to a refund equal to the amount You have paid for the latest term.

Right to Change Content or Format

You acknowledge that AFFNETWORK LIMITED may from time to time, and in its sole discretion, update or change the content or format of checknumber API Data or the checknumber API. AFFNETWORK LIMITED shall strive to provide reasonable advance notification of such changes; however, from time to time sudden changes may be required, and since AFFNETWORK LIMITED strives to accurately reflect these and adjust to these changes, significant advance notice is not always possible. You may be required to use the most recent version of the checknumber API in order to ensure functionality of Your application(s) with checknumber API Data & Services.
